TYPES AND BENEFITS FOR HAVING AN ACTIVE MEMBERSHIP IN CARSAMPAF.

As established by our regulations, in its Chapter V "On the Registry of Members", in its Article 8, in its Subparagraph b) "On the Categories of Committee Memberships" The following categories of Committee Memberships are considered:

Individual Members: By registering in this category, you have included the right to attend the Annual Meeting and Conference, as well as the Ordinary and Extraordinary General Assemblies, convened by the Board of Directors with the right to vote, and will have a preferential cost of 50% discount. for attendance at Committee events or activities. They will pay the annual membership registration fee.

Business Members: Private Companies are included in this category, which upon registration will have 4 (four) seats so that their representatives can attend the Annual Meeting and Conference, as well as the Ordinary and Extraordinary General Assemblies, convened by the Board of Directors with the right to a vote per Company and will have a preferential cost of 50% discount for attendance at events or activities developed by the Committee. They will be able to make an exhibition of a topic of technical and promotional interest) of their services. They will be able to place their logo, and business page link in our Web Portal, and will have an additional fee for this option, which will be established and updated by the Board of Directors. They will pay the annual membership registration fee.

Organizational Members: International Organizations are included in this category, which upon registration will have two (2) places to attend the Annual Meeting and Conference with a preferential cost of 50% discount. They may participate with a Delegate or representative with one vote, for the Ordinary and Extraordinary General Assemblies, convened by the Board of Directors. They will be able to make a presentation on a topic of technical interest. They must register as members, but will not pay the annual fee.

State Members: included in this category are the AACs, who upon registration will have four (4) places to attend the Annual Meeting and Conference at no cost. They may participate with a Delegate or representative with one vote, for the Ordinary and Extraordinary General Assemblies, convened by the Board of Directors. Their representatives may also participate, free of charge, in the workshops or training programs in accordance with the quotas established for this purpose. They must register, but they will not pay the annual membership registration fee.

Honorary Members: This category will have the former members of the Board of Directors, and those who have provided services of relevance and transcendence to the Committee. The annual payment is exempt, and their attendance at all the activities carried out annually is included at no cost.

MEMBERSHIP COST.

The annual membership to belong to CARSAMPAF as an Individual Member has a cost of \$50 (Fifty US dollars). If your company wants to become a member of CARSAMPAF, the annual Business Membership costs \$170 (one hundred and seventy US dollars).

MEMBERSHIP CERTIFICATION.

To accredit your participation and the validity of your membership, a certificate will be issued by the presidency on behalf of the Board of Directors. In the same way, an official list of registered members will be published on our website, where it can be consulted.
